Meeting with Delegation of Punjab Public Service Commission

A Meeting was held on 06th January, 2025 at FPSC Headquarters, Islamabad with higher level delegation of Punjab Public Service Commission. The agenda of the meeting was to discuss bilateral/mutual issues relating to interview and examination system. The meeting was chaired by the Secretary FPSC, senior officers also attended the meeting.

Coordination and Implementation Meetings

Presided by Chairman FPSC, Coordination meetings are regularly held to ensure structured, efficient, and result oriented informed decision making. In this regard four meetings were held

Activities Relating to CSS Competitive Examination during January-March 2025

on 21.01.2025, 04.02.2025, 28.02.2025 and 26.03.2025 respectively.

Special CSS Competitive Examination 2023

- Psychological Assessment of 382 candidates and Viva Voce of 386 candidates was conducted during the quarter January-March, 2025.
- Medical examination of 518 written qualified candidates was arranged and carried out during the quarter January-March, 2025.

- Personal hearings of 02 rejected candidates of Special CSS CE-2023 were conducted during the period January-March, 2025.

Competitive Examination 2024

- Post examination detailed scrutiny of 15602 candidates of CE-2024 remained under progress during the quarter under report.

Competitive Examination 2025

- 18139 Online applications for written part of CSS CE-2025 were received and processed during the period 23.12.2024 to 06.01.2025.
- Written part of CSS CE-2025 was held simultaneously at 19 cities from 15.02.2025 to 23.02.2025. Salient features of the exam are as under:

Activities relating to General Recruitment (January-March) 2025

- During the quarter, January-March 2025, FPSC advertised 30 cases involving 105 vacancies relating to BS-16 and above belonging to different Ministries, Divisions and Departments. Against such vacancies, 44,022 applications were received online.
- Under general recruitment stream, Professional Screening Tests/Written Descriptive Test Phase-I/2025 were held involving 12 cases comprising 32 posts. For this test phase, 2917 applications were received and 1065 candidates appeared in the tests.
- 26 requisitions from Ministries/Divisions/Departments for advice on Recruitment Rules were received and processed.

Other activities performed by the FPSC during (January- March) 2025

- During the quarter January-March, 2025 the Commission conducted interviews and personal hearings of 3659 candidates.
- The Commission prepared test schemes and syllabi of 30 cases of general recruitment involving 105 posts of BS-16 and above as referred to the Commission during first quarter of 2025.
- FPO examination-2025 of eight occupational groups was conducted during January-March, 2025.
- Result of SOPE-2024 for induction of section officers (BS-17) announced on 28.01.2025. Against 39 posts, 1151 candidates were registered. Out of them, 356 appeared in the examination whereas 33 candidates qualified the written part.
- 43 appeals/petitions relating to General Recruitment cases were decided at various forums.

- 57208 SMS and 7181 e-mails were sent to the candidates on their given cell phone numbers and e-mail addresses acknowledging their online applications and intimating about major events including, schedule of tests, interviews, personal hearings etc.
 - Over 6077 e-mails, concerning queries & clarifications of the applicants, were received and appropriately responded during October-December 2024.
 - E-Office is deployed in the FPSC for improving efficiency and cost saving.
 - E-Library deployed with 2 apple systems. Total 51,358 books were made available.
