INSTRUCTIONS:

For fresh candidates/ absent candidates:

- a. Bring original CNIC alongwith one attested photocopy and two latest passport size photographs (attested backside).
- b. Bring following Computerized Laboratory Investigations:
 - i. (a) Chest X-Ray alongwith report (b) Pregnant female candidates should get an Ultrasound of Pelvis with report done instead of Chest X-Ray (c) ECG alongwith report.
 - ii. Complete Blood Count (CBC).
 - iii. Blood ESR
 - iv. Fasting Blood Sugar (FBS)
 - v. Hepatitis "B" Antigen (Hbs Ag)
 - vi. Hepatitis "C" Antibodies (HCV)
 - vii. Liver Function Test (LFTs)
 - viii. Urine Detail Report (Urine DR)
 - ix. Serum Lipid Profile (12 hours fasting)
- c. Candidate wearing glasses should get themselves examined by any Government Eye Specialist and bring Fresh prescription alongwith glasses at the time of Medical Examination.
- d. To facilitate medical examination, candidates are advised to put on underwear.
- e. Following fees may be deposited in Government Treasury/State Bank of Pakistan and both original treasury challans may be handed over to the Medical Board at the time of your Medical Examination:
 - i. Rs. 100/- is required to be deposited under Head of Account "C-02839-Health Fee for Medical Examination" ([Rs. 100 Challan Form](#))
 - ii. Rs. 2,000/- is required to be deposited under Head of Account "C-02725- Collection of Payment for Services Rendered (NHSR&C)" ([Rs. 2,000 Challan Form](#))
- f. No TA/DA for attendance at CMB examination is permissible under the Rules.

For medically deferred candidates:

- a. Following fees may be deposited in Government Treasury/State Bank of Pakistan and both original treasury challans may be handed over to the Medical Board at the time of your Medical Examination:
 - i. Rs. 100/- is required to be deposited under Head of Account "C-02839-Health Fee for Medical Examination" ([Rs. 100 Challan Form](#))
 - ii. Rs. 2,000/- is required to be deposited under Head of Account "C-02725- Collection of Payment for Services Rendered (NHSR&C)" ([Rs. 2,000 Challan Form](#))
- b. No TA/DA for attendance at CMB examination is permissible under the Rules.
- c. **Candidates are advised to fulfil medical requirements (i.e. reduced weight, fresh lab tests etc.) as conveyed to them individually by the Central Medical Board.**

2. In terms of Rule 13 (7) of Competitive Rules, If any candidate remains absent twice in his/her medical examination, his/her candidature will automatically stand rejected and no appeal in this regard will be entertained. However, his/her chance will be considered as consumed.
