- 4. Remaining candidate(s) in the subject case are either <u>low in order of merit / fail</u> in Screening (MCQs) Test and will not be called for interview. It may be noted that no further communication to FPSC shall be made in this regard.
- 5. <u>Important Note</u>: The names and number of provisionally shortlisted/rejected candidates are subject to modification after Commission's decision on the representations and review petition (if any) of rejected candidates in terms of Section 7(3) of Federal Public Service Commission Ordinance, 1977.
