Dear Candidate,

Referring your online applications for the subject post, following candidates are advised to furnish **BIO-DATA along with attested copies (with name stamp of attestation officer) of requisite documents as mentioned below, within 15 days (up to 21st May, 2024) of placement of this Notice on FPSC website, through Registered Post/Courier to determine their eligibility**. It may however, be understood that asking of requisite documents should not be inferred that the candidate have been shortlisted for interview and their eligibility in all respects in terms of advertised conditions shall be determined after scrutiny of their documents:

- a) Bio-data form duly signed and filled-in completely Bio-data Form is available in downloadable Form on following link <u>https://www.fpsc.gov.pk/downloads/forms</u>.
- b) Two latest Photographs (Passport size).
- c) Valid Computerized National Identity Card (CNIC).
- d) Self **Domicile** Certificate (SDC).
- e) Secondary School Certificate (SSC)/Matric (showing date of birth) and Higher Secondary School Certificate (HSSC)/ Intermediate issued by Secretary, Board of Intermediate and Secondary Education. In case of 'O' level and 'A' level an equivalence certificate from Inter Board Committee of Chairmen (IBCC).
 f) Minimum Qualification, Post Qualification Experience and Research Work:

<u>a). Minimum Qualification:</u>

i).MBBS or equivalent Medical qualification recognized by PMDC. OR M.Sc. of a recognized University in case of basic science in the relevant subject (for Non-Medical graduates).

ii). DSc., Ph.D., FCPS, MD, M.S., M.Phil. etc. in the respective subjects. FCPS / MD with DPH (for Public Health Institutions only). OR equivalent qualification recognized by PMDC.

b).POST QUALIFICATION EXPÉRINCE:

Five (05) Years teaching experience as an Assistant Professor in the respective subject in the postgraduate institute only. OR Eight years teaching experience as Assistant Professor in undergraduate Medical Institution.

c). Research Work:

Must have produced at least three (03) research papers.

Must have produced at least Five (05) research papers if teaching experience is in undergraduate institution. Note:

i). For all Basic Science subjects a non-medical is eligible provided a medical graduate with requisite qualification is not available.

ii). For appointment as Associate Professor candidates possessing a D.Sc. / Ph.D. Degree the thesis or major subjects should be related to the subject in which they are appointed / promoted.

iii). Candidates without a Basic Medical qualification are eligible for appointment as Associate Professor provided they possess at least D.Sc. / Ph.D. Degree and provided a medical graduate with the requisite qualification is not available.

- g) Degree(s) and Transcripts/ Result-Cards/ DMCs showing duration of study period, credit hours with proof of CGPA/ Grade/ Class with credit hours and Result Declaration Date, issued by Controller of Examination from a University recognized by Higher Education Commission (HEC) to determine eligibility.
- h) Wherever an equivalence of the required degree is to be claimed by a candidate, an equivalence certificate issued by HEC/PEC/PMC/PNC may be furnished to FPSC to authenticate the claim.
- i) Valid **Registration** with HEC/PEC/PMC/PNC and such other institutions where applicable (if any).
- j) **Experience** Certificate (Post Qualification) with Job description and exact dates as per detailed Experience Format (Annex-A available on FPSC's website), where applicable.
- k) In case of **Government Servant**, Original Departmental Permission Certificate (**DPC**) showing exact date of appointment and domicile on FPSC's prescribed format (available on FPSC's website) duly signed and stamped by Head of the Department/ Division/ Ministry (Official stamp must be affixed).
- In case of Non-Test Case or UNDERTAKING provided by the candidate at the time of examination, Original Treasure Receipt (TR) being application fee deposited on or before the closing date of the advertisement in the Government treasury or in a branch of National Bank of Pakistan or in a State treasury, authorized to transact business on behalf of Government.
- m) Medical Certificate (if required/advertised) and Proof of Age Relaxation (if claimed).
