## NOTICE FOR DESCRIPTIVE TEST

## SUBJECT: - RECRUITMENT TO THE POST OF INSPECTOR CUSTOMS/ INTELLIGENCE OFFICER (BS-16), REVENUE DIVISION, FEDERAL BOARD OF REVENUE.

Referring their online applications and subsequent appearance in Screening (MCQ) Examination for the subject post, undermentioned fourteen (14) candidates are shortlisted for descriptive test as per decided policy of the Commission, that a two (2) stage testing for BS-16 and BS-17 level post pertaining to sub set of FIA and FBR cases, on the basis of merits position in the result of MCQ Screening Test, ten (10) candidates (if applicable) per vacancy from respective quota would be shortlisted for descriptive test.

All the above listed candidates are cautioned that their appearance in the Screening (MCQ) Test and Descriptive Test shall be provisional subject to their eligibility in terms of Recruitment Rules and the advertised conditions, which shall be determined after the Descriptive Test. On detailed scrutiny of the applications if they are found ineligible, their candidatures will be cancelled irrespective of the fact whether they have appeared in the examination/ test or even qualified therein. On rejection of applicant's candidatures on the basis of their ineligibility, the applicants would be informed by the Commission describing the reasons of their ineligibility. The rejected candidates on submission of their representations shall be heard by the Commission's Committee. The candidates should therefore make sure before appearing in the examination/ test, that they are eligible in all respects for the subject post.
- 4. Syllabus and schedule for Written Descriptive Test will be displayed on FPSC's website in due course of time. Candidates are advised to keep themselves informed about updates placed on FPSC's website.
