The 166th meeting of the Commission was held on 6th June, 2023 in the Conference room, Federal Public Service Commission, Headquarters Islamabad. The meeting was presided by Mr. Fazal Abbass Maken, Senior Member of the Commission. The meeting commenced with recitation from Holy Quran. Agenda of the meeting included deliberations on recommendations of the Commission's Committee to enhance the effectiveness of MPT, proposals of Minister Planning, Development & Special Initiatives and amendments in SOPE Rules-2015 etc.

iii. Conduct of MCQ based Preliminary Test (MPT) prior to Special CSS Competitive Examination-2023: FPSC with the approval of the Federal Government conducted MPT on 21.05.2023 for Special CSS Competitive Examination-2023. Special CSS will be held to fill against specific quotas/ vacancies which remained unfilled over the last many years in CSS Competitive Examinations due to non-availability of qualified candidates. The result of MPT for Special CSS was announced on 27.06.2023. Out of 54 257 applied candidates, 38445(71%) appeared in the examination. In all 33157(86%) candidates qualified MPT. While, 2001(5%) were declared unsuccessful, result of 3287(9%) candidates was withheld which is remained under process till reference period.
