No. 4/10/2006-R-2 dated 18.03.2020, and the notification SRO No. 747(I)/2020 dated 19.08.2020.

3. The allocation of candidates to various Occupational Groups and Services shall be made based on their merit positions, suitability as determined by the Commission, stated preferences and respective domiciles.
